She co-chairs Canadian Association of Jews and Muslims (CAJM), and cofounded "Together in Hope", a Jewish, Palestinian/Arab women's dialogue group.

Dr. Julie Macfarlane is Professor of Law and



Distinguished University Professor at the University of Windsor. She has researched and written extensively on dispute resolution and in particular the role of lawyers. Her books include The New Lawyer: How Settlement is Transforming the Practice of Law
